This Document's Purpose

The purpose of this document is not to dissuade any person from having faith in their current form of government or society, (no matter how deeply flawed the logic such beliefs may be,) as Advancementism also has its flaws. There will always be those that wish to live outside the societal boundaries and others whom with to attempt (with varying degrees of success) to manipulate the societal rules and norms for personal gain at the expense of others. This document has been created to provide insights and clarity about the terms “Advancementism” and “Advancementistic Society” with regard to their use by the author since the latter part of the year 2019. This document is intended to provide an overview and not designed to be a comprehensive study of all facets of how Advancementism may be realized. Furthermore, this document is not designed to be used for indoctrination into the belief that an Advancementistic society is in anyway superior to other societies due to the fact (as previously mentioned) all societies have flaws and include persons and non-person entities that wish to put their own interest above the safety and well-being of others. Furthermore, the terminology used in this document is fairly arbitrary (with the exception of the terms “Advancementism” and “Advancementistic Society”) so any connotations, implications, nuances, or other non-strictly defined (by this document) meanings should not be considered when reviewing this document and using these terms.

Advancementism Defined

Advancementism is the societal construct which places the advancement of the entirety of the group as the center of prosperity. Whereas people seek money in capitalism, in advancementism people seek the betterment of the core of society. In capitalism people are able to achieve higher social classes and diverse levels of prosperity by gaining more money; in advancementism advancementists gain higher social recognition, prosperity, and influence by increasing the quality of life and upward mobility of the core of humanity.

The Core

The core is not a class of society, rather it is a minimum standard of living that has been extended to the entirety of the population of earth. It is not only the people but also the fundamental understanding that all people should be entitled to a minimum level of humanity that includes all things needed to maintain a healthy, content, and meaningful life.

Defining the Core

Everyone whom is born on earth is part of the core. This is where everyone begins on an equal footing with equal access to privacy, autonomy, education, healthcare, housing, electricity, water, and advancementistic services. The core is a minimum standard of life that is required to be made freely available to every earth citizen that wishes to partake. As such, no identification, insurance, or money is needed to acquire health care, education, or other publicly available resources. The core is a regionally defined population that may consist of sub-continent or current national boundaries.

Creating a global baseline

Currently, there is no global standard for quality of life and no baseline has been created that measures the disparities of quality of life across regions. This creates a problem because there is no

way to improve what you have if you do not know what you have. Therefore, an initial step in creating a global population is to evaluate the quality of life across the entire human element. Once a baseline has been created it is critical that resource are pooled from many places to bring the areas with diminished quality of life to be equal with the standard quality of life of the more advantaged areas. This does not mean all peoples in all regions have the same quality of life as those which currently experience superior life-styles in more affluent regions, it means the standard quality of life is raised up to meet an agreed upon standard.

Consolidating the cores

Once the baseline has been established and a standard has been created it will be time to consolidate the core. Core consolidation is just the practice of implementing the standard across the core. Consolidation is the assurance that the entire population of the core has readily available and easy access to the provisions of the standard without being forced or coerced in conforming to any requirements to being permitted access to such provisions. Consolidation provides access to the core but is not designed to force core population members into accessing those rights and services provided by the standard.

Advancementists

There are individuals whom want to contribute to society, to be renowned, recognized, have a seat of admiration and popularity, or otherwise be considered to be great humans or recipients of greater rewards. In an advancementistic society these people are those which create solutions that advance the quality of life of the core. These people create ideas that are used to realize real benefit for the whole of society. In return, advancementists are rewarded for their contributions.

Creating ideas and submitting to Core Maintenance

When an unknown core member wishes to bring an idea into realization by creating an invention the core member can submit the idea to Core Maintenance for public support. If Core Maintenance decides the idea or invention has the potential to be of benefit to the members of the core (the whole of society) then Core Maintenance supports the idea. This support comes in the form of access to advanced laboratories, assistants, and collaboration opportunities for a predefined period of time. Once the time has concluded the core member must present the idea to the core for adoption or further Core Maintenance support. If Core Maintenance chooses to not support the idea the core member has the opportunity to bring the idea to life using individual or private resources.

Utilizing personal resources

If a core member wishes to use personal or private resources to develop an idea that is fully acceptable. The core member is permitted to do so without any restrictions that are not tied directly to the safety of the core. For instance, if a core member wanted to test a new hydro-electric means of storing data it may be prudent to require the research be away from any areas that could be harmed by large amounts of water, electricity, or the combinations of the two. Once a core member has developed the idea they are able to present the idea to Core Maintenance (without restriction) for consideration for private idea testing and adoption.

Test Invention

When a private of Core Maintenance supported idea has come into fruition it must be tested. The testing process must be completed by the advancementist who designed the idea and/or the support

staff that has been ingratiated in the development of the idea. Once this testing have been completed it is submitted to Core Maintenance for review, verification, errors, implications, and safety recommendations and guidance.

Rewards (awarded exclusive time in advanced industry labs and tech)

The rewards for advancementists whom successfully contribute to the increase in quality of life to the core or to the coalition of cores depends on the motivations of the individual and the incentives provided by Core Maintenance. There are some universal rewards that are bestowed upon those that have been formalized as advancementists though. The universal rewards include exclusive use (for a predefined period of time) of advanced Core Maintenance laboratories to assist in the development of potential future core advancements, exclusive access to resorts with specific exclusivity for formalized advancementists, the option to become a public figure with dedicated media spots discussing the advancement. These universal benefits are extended to the advancementist for a period of five years after the formal adoption into the core of the advancement.

Regressionists and Edenists

As with any society there are elements whom will wish to challenges the construct of the society and/or cause harm to the societal foundations and population. Presently these individuals are called “criminals” with the most extreme form of criminals called “terrorists”. In Advancementistic societies these people are called “regressionists” with the most extreme form of regressionists called “Edenists”. When regressionists commit atrocities against society they are charged for their behavior based on the Advancementistic legal framework. This framework is built upon rejuvenation, rehabilitation, and inspiration of the offender. The alleged offender is charged with crimes against the core (or coalition of cores for Edenists), tried by a selected subset of regional core members, if found culpable the individual receives a punishment and rehabilitation sentences. An attempt at a simplistic overview of these steps is portrayed here.

Charges

When a core member (to include advancementists) are accused of causing harm to the core (anything from minor theft to homicide to criminal negligence, to intentional fraud for persona gain) a determination is made about whether or not the individual is a physical or serious psychological safety risk to members of the core. If it is determined the individual does constitute a physical or serious physiological risk to members of the core the individual is confined to legal quarters. Legal quarters are much similar to an apartment complex found in most rural areas. They house multiple people, have plenty of surrounding landscape, and offer easy access to local grocery and consumer stores. More serious physical offenses being permitted to have more restrictive confinement options none of which include solitary confinement for an extended duration or imprisonment. If the person is not determined to be a physical or psychological risk to the core the individual is permitted to maintain their presence at the individual’s current residence. During the issuance of charges the individual has the opportunity (and right) to maintain privacy. The privacy standard states the charges can be made available to the core but the person whom was accused of committing the offenses must remain private and not be disclosed to any person other than those whom have issued the complaint and those whom need to directly correspond with the individual whom has been charged.

Trial

Before the trial begins the accused can (and has the right to) remain anonymous throughout the duration of the trial. If the accused wishes to exercise this right the witnesses are not permitted to use the name of the accused during any testimony, the core members whom are deciding culpability are not permitted access to the accused's identity, and the presiding official has no knowledge of the identity either. The number of core members which are selected and how the core members are selected depends on the local core policies. During the trial the accused has the right to use a defense specialist (defense attorney) to question the accuser and provide a reasonable defense to include any special considerations that should be considered. The only question the core members are responsible for answering is "did the actions of the accused hurt members of the core".

Punishment

If the core members find the accused is culpable the presiding official is charged with ensuring the punishment and rehabilitation is appropriate. The punishment is designed to be a public service requirement which also provides the accused the ability to learn or progress a skill and should take into consideration the interests, skills, and abilities of the regressionist. For instance, if a regressionist is passionate about the treatment of animals the punishment may be a requirement to spend time working with a local organization that helps local animal life. Only under the most insidious of crimes, or crimes where physiological conditions need to be addressed to prevent violence, are accused punished to confinement in a specific facility.

Rehabilitation

As part of the sentencing phase (due to lack of more accurate terminology) the presiding official also works with the accused to develop a rehabilitation road map that will assist the accused ingratiate with the core in a way that is rejuvenating and revitalizing. The purpose of the rehabilitation is to ensure the accused is seamlessly supported as the accused regains full individuality and independence. This portion is nearly completely defined by the accused and is fully supported by the Advancementistic legal framework to assist in recidivism prevention.

Core Maintenance Providers

The Core Maintenance Provider is the regional governing entity. The structure and power of this entity is strictly limited to supporting Advancementists and Advancementist organizations, ensuring even and equitable management of the core based on the standard, participating in the coalition of cores, and presiding over the legal process of accused organizations and individuals.

Protect and Support Advancementists' Ideas and Products

The primary responsibility of the Core Maintenance Providers is to ensure Advancementists are able to create advancements to raise the quality of life for the core. In this effort the Core Maintenance Providers are responsible for ensuring members of the core are able to easily submit ideas for consideration of support while ensuring the ideas submitted are unique and accredited to the legitimate owner. All ideas that are submitted must meet a minimum standard of completeness, meaning they must be fully formulated ideas that can actually be used to produce the discussed benefit. All ideas must also be original or a request to review a previously denied idea. Any denied ideas can receive a request to be reviewed for future consideration. If an idea is denied a details explanation must be provided detailing the reason for the denial and, if the denial was due to

incompleteness or inaccurate paperwork must include ways to resubmit the idea and how to correct the deficiencies.

Submit to Core Maintenance Provider for evaluation and implementation

Once an advancementist submits an idea it is processed for completeness and uniqueness. If it passes this challenge it is forwarded to the next round where it is reviewed for potential negative social impacts. If it is denied for potential negative impacts the decision can be reviewed (by request of the advancementist) through a request to forward the idea to a neighboring Core Maintenance Provider. Any such requests for review must be free from complexity and performed in a timely manner. If the idea is found to be unique, complete, and free of negative social impacts it is forwarded to the support decision round. In this round of reviews the idea is scrutinized for possible positive benefits it offers to the as well as the percentage of the core that will benefit from the advancements. If less than 85% of the core benefits from the advancement it is rejected with recommendations to increase the coverage. At this point the Core Maintenance Providers also determine if appropriate facilities and staff are available to support the idea. If the idea is approved and no staff and facilities are available the Core Maintenance Providers put out a public call to retain staff and then build appropriate facilities to realize the idea.

Dissemination

Once the idea is realized the advancement is disseminated through the core using a methodical strategy for implementation. This strategy should have been planned in the idea documentation that was submitted to the Core Maintenance Provider at the beginning of the process but may have changed as the idea was realized. Dissemination can be performed simultaneously across the entire core or it can be continuously deployed across the core in stages.

Verifying distribution of Core services

Once the dissemination phase is completed the newly added advancement must be verified and measured. The metrics and verification processes contained in the original idea documentation should be used and adopted by the Core Management Provider to ensure coverage goals are being consistently met across the entirety of the core. All core services are opt-in services that are freely available to everyone without any requirements associated.

Handling disputes and inconsistencies

In the event of an inconsistency of the advancement among the core, the Core Maintenance Provider determines if this is due to a cultural decision to not-adopt (people are choosing not to opt-in), if the newly added core service has not been properly communicated and publicized, if the process of acquiring the service is too complex or if there are any other reasons for inconsistent adoption. If the reason is a lack of opt-in for the advancement the issue is annotated as an acceptable deviation from the expected outcome. If there is a different reason for disparities the Core Maintenance Provider works diligently to restore equality across the core.

The Coalition of Cores

Cores are regional societies (current national boundaries, portions of continents, or entire continents) that constitute only a portion of the population of earth. The Advancementist Society is an entirety of earth society that is composed of multiple cores. The Coalition of Cores is basically a Core Maintenance Provider for Core Maintenance Providers as described in this section.

Core Maintenance Providers

Core Maintenance Providers are regional governance bodies that oversee the advancement of the minimum quality of life across the entire society. These are akin to what we currently call governments. The chief responsibility of Core Maintenance Providers is to support and bring to fruition those ideas, from community members, that will increase the minimum quality of life for 85% or more of the core (population).

Coalitions

Coalitions are groups of Core Maintenance Providers that act as peers when deploying new advancements to their cores (populations). In a coalition a single Core Maintenance Provider may fully deploy an advancement that has raised the quality of life of its core then make that advancement available to a coalition member for initial proof of cross-regional benefit. This permits Core Maintenance Providers the ability to make advancements available for testing by other Core Maintenance Providers in a controlled way before submitting the advancement to the Coalition of Cores.

The Coalition of Cores

The Coalition of Cores is a global governance body that has the same roles and responsibilities as the Core Maintenance Providers but the scope of those roles and responsibilities is global. Instead of individual core members (members of the public) submitting ideas for support, Core Maintenance Providers submit advancements for adoption. All submitted ideas must be deployed across at least three cores by three Core Maintenance Providers in geographically dispersed regions with full documentation on benefits, adoption rates, negative consequences, and side-effects/unanticipated results.

Industry

Industry plays much the same role in an advancementist society as it does within a capitalist society with only a few key differences. Industry in an advancementist society still develops new products and technology for public consumption but the focus is on promoting increased levels in quality-of-life and not on profits. Industries in advancement societies are much more willing to collaborate in vertices where proprietary advancements are not being created for organizational support from the Core Maintenance Providers.

Maintain Core Life

A large number of “for profit” vertices that currently exist would be transformed into core maintainers in an advancementist society. This does not mean they would fall under the authority of the Core Maintenance Provider (they can be private entities) but it does mean they would need to conform their business practices to the advancementist society. The standard core services would

be offered for free to all members of the core without any requirements for identification or prohibitions while things that are above the core standard could still require certain conditions such as payment or reciprocity (you can use our golf course if we can use your spa).

In Closing

No society is perfect and every society is ripe for abuse is the core population of those societies permit the leaders to perform such abuses. This document is not designed to promote any society or indoctrinate anyone into any belief system about any society. The publication of my understanding of an Advancementistic society is purely to furnish clarity around terminology I have used.
